#### 6. APPROVE TREASURER'S REPORT – (ACTION)

@ 10/31/20

- Personnel is 4% under budget primarily related to lower film maker wages.
- Operating expenses are 30% under budget as expenses for accounting services from Scandia have only been billed through June.
- Other supplies are \$160 over budget or 18%
- Facilities and Equipment Rent increased (1.5%) with October payment for November per lease agreement.
- Expenses less Equipment are under budget by 5%
- Revenue: Both Columbus and Forest Lake are behind (Paid until August \$30,000 is owed by year-end)
- Midco- Access Fees- up 4% vs budget
- Cash Balance is \$168,637.77, with reserve: \$193,733.65
- Cumulative Cash reserved for equipment \$56,682

LATV is budgeting well and has the availability to put an extra \$5000.00 in the reserves for the Franchise agreement that will need to be redone in 2028.
