#### 6. APPROVE TREASURER'S REPORT – November 2021

(ACTION)

- Employer/Personnel expenses on budget
- Film Makers wages are under 27% budget
- Office Supplies are 36% under budget over all
- Operating expenses 13% over Budget due to paying Scandia for 2020 Auditing/Accounting services in 2021.
- Facilities and equipment, Rent is on budget (1.5 % annual increase effective for Nov) Tierney Premium was misclassified, putting total Fac & Equip 8% over budget
- Franchise Reserve is over budget due to a \$30,000 additional transfer in July 2021
- Non-Peg expenses are 24% over budget
- Franchise Fee Revenue: under budget. Forest Lake is 1 month behind
- PEG/Midco Revenue is under budget 13.5% Due to Midco behind in payments
- Total cash used YTD is \$37,247.86
- Total Cash disbursements to date \$196,755.87 and Total Revenues YTD \$159,508.01.
- Cash Balance is \$142,470.80, with reserve: \$202.587.34
- Cumulative PEG revenue reserved for equipment \$62,001.80

#### 7. REGULAR AGENDA

A. Health Insurance -Discuss

Paul Switched policies which reduced the premium. Paul's portion will be lower by about \$520/yr and the station's portion will be lower by about \$1,900/yr. Total savings over \$2,400/yr.

#### 8. ACCESS COORDINATORS REPORT

- The Carousel System LATV uses has been having continual issues, so Paul is planning on purchasing a new system in 2022. Cost could range between \$20,000-\$40,000
- Paul questioned what to do with Columbus meetings, Sue said she would talk to Elizabeth at the City of Columbus to see if LATV can get copies of the meetings to air on the channel or what they would like to do.
- Taco Daze is finished. Payment has been sent to LATV
- Paul is helping the school research some equipment to aid in filming events, in the process he
  found a new streaming device that he purchased for the station. He purchased it for about
  \$1,300 and wanted to let the Commission know that it was over the agreed upon amount. This
  device may also be purchased by the City of Forest Lake to use in the conference rooms that
  do not have cameras.
- The equipment LATV purchased from Savage a couple years ago will be used in the school auditorium to film concerts
- LATV filmed an event for LILA using their new equipment and to show them how.
- LATV is working with CSF, a business in town, to film a promo video for a community scholarship
- LATV is starting to film for the Hockey team to make an entrance video for the "world of Hockey" for the girls' hockey team to submit for a chance to play in another league.
- LATV is filming 5 of boys and girls hockey games this season, which was decided and agreed
