## 6. APPROVE TREASURER'S REPORT – September 2022

(ACTION)

with revisions 11.4.22

- Employer/Personnel expenses including total wages are 2.2% under budget
- Offices Supplies are 56% under budget
- Operating expenses are 5.3% under budget
- Facilities and Equipment are 5.2% or \$1,035 over budget YTD
- Production services Revenues are 10% over budget
- Building rental is on budget (1.5 % annual increase effective in Nov)
- Total PEG/Midco Revenue is 4.6% under budget (about \$2,000 for the year)
- New PEG equipment purchased from PEG Revenue is over YTD Budget by 31.6% or \$12,633 due to the new Tightrope system. Expected to be at budget at year-end.
- YTD PEG Revenue is less than PEG Equipment Expenses by (\$12,867.35)
- YTD PEG expenses: \$42,633.71
- Cumulative PEG Revenue Reserved Balance for Equipment is \$54,388.32
- Cash Balance YTD \$87,499.56 with reserve + int: \$207,637.01 (includes \$120,000 in CD)
- \$120,000 was transferred to a 1-year cd (Renews August 9<sup>th</sup> of 2023)
