# 7. REGULAR AGENDA

#### A. New Media Sales (ACTION)

Tim presented a new plan for media sales, He asked for LATV to try a sales partnership plan with the schools/booster clubs to help with DVD sales. Tim also added that LATV would like to look into other media sales options like USB drives, digital downloads and Blu-ray discs. The partnership would give the schools/booster clubs a \$3 kickback for helping with the sales. They would only get this \$3 during the first 30 days after the initial creation. Tim presented price suggestions for each product.

This plan is similar to a policy that LATV used in the past. Tim asked commission for approval to look into the partnership again.

Diane said she would like to see a more detailed formal plan with costs & revenue projections. Dianne referred to a pricing plan that was in place in 2011.
